

JOB DESCRIPTION: (Part-Time) Home Care LPN Nurse

Working in collaboration with the NHSS Home Care LPN Team Lead and Home Care Staff, the part-time Home Care LPN Nurse is responsible for carrying out client care plans as assigned by the HC Nurse Manager delivering nursing services to our clients. This position operates from a holistic perspective and the Home Care LPN Nurse works with the Home Care staff to assist clients in attaining and maintaining their good health. The Home Care LPN Nurse works collaboratively with the Home Care Team, other NHSS staff, and stakeholders within the twelve NHSS communities to carry out assignments and participate in events in a respectful and culturally appropriate manner. In this position respecting confidentiality is key; tact and discretion must be exercised in all interactions with others.
